

RELEASE OF LIABILITY

A) AGREEMENT TO FOLLOW INSTRUCTIONS

It is my desire and intent that the words, terms, provisions, covenants, and remedies contained in this Agreement shall be enforceable to the fullest extent permitted by Applicable Law. If any portion of this Agreement is held invalid, the remainder shall not be affected and shall continue in full force and effect.
